The Kickstart Scheme

The Kickstart Scheme is a £2 billion fund to create hundreds of thousands of high quality 6-month work placements for young people aged 16-24, who are claiming Universal Credit. Employers of all sizes looking to create quality jobs for young people can apply. Through the scheme, all organisations across the private, public and voluntary sectors will be able to access a large pool of young people with potential, ready for an opportunity. The Government will fully fund each 'Kickstart' job – paying 100% of the relevant National Minimum Wage for 25 hours a week, plus the associated employer National Insurance contributions and employer minimum automatic enrolment contributions.

The DWP has produced A Guide for Employers and there is a page for young people on the job help website.

Key details:

- Job scheme and employers can claim wages
- On top of the wage subsidy, £1,500 per job placement available for setup costs, support and training.
- Employer applications are for minimum 30 job placements. Employers can partner with other orgs to reach the minimum number.
- If an employer organisation is creating fewer than 30 Kickstart job placements, they must partner with others which could include:
 - similar employers
 - local authorities
 - trade bodies
 - registered charities

Action:

There will also be funding available to support young people to develop new skills and to help them move into sustained employment after they have completed their Kickstart Scheme funded job therefore you may wish to work with your Job centre plus and the employers who going to use the scheme to see if you can supply the training.
