#### Covid-19 update

You will be aware that the Government announced the new tier system last week and many parts of country are under different restrictions. Hampshire is currently under tier 1. Please note that should this change, the guidance for education remains the same and is not

affected by the tier system; it is still expected that after you have risk assessed (centres and travel), and provided a safe environment you will open for face to face teaching, supplemented by online.

"Education is exempt from any of the restrictions in all alert levels so they should remain open. Provider risk assessments should be continually reviewed and adapted. All education providers should remain open under any circumstances, particularly for vulnerable learners but also if they have 16-19 students to meet the requirement that the majority of their planned hours are on site. If you have clear documented public health advice that you need to substantially restrict on site attendance you should engage with ESFA territorial teams ahead of taking and communicating action."

### **Data Entry Reminder**

Please ensure colleagues have access to, and have read the updated <u>Data</u> <u>Collection Guidance Notes 20/21</u>, as we are already starting to see courses being entered on to EBS late e.g. after the course has started.

...For most courses, the course information should be on the MI system at least six weeks before the start of the course to take advantage of the opportunity for increased publicity from appearing on local and national course search websites. Courses that are not to be advertised to the general public may be added at the shorter notice of two weeks before the course start. Courses added within two weeks of the start date will only be funded with the prior approval of the Programme Manager. Courses due to be led by a new tutor, or a tutor who has not been observed in the academic year, that are entered within two weeks of the course start date will only be approved in exceptional circumstances. Courses that do not appear on the MI system before the start of the course will not be funded...
