### Family Rights Group

Helping Families Helping Children

Free, independent, confidential advice service for families:

The purpose at Family Rights Group is to help children live safely and thrive within the family and community. They are a charity that advises parents, grandparents, relatives and friends about their rights and options when social workers or courts make decisions about their children's welfare. They work with parents whose children are in need, at risk or are in the care system and with wider family members and friends who are raising children (known as kinship carers). We work with many local authorities through our [Family](#)



[Group Conference](#) and [Lifelong Links](#) network, and our [training and consultancy packages](#).

They also offer a **free, independent, confidential advice service for parents, kinship carers, grandparents, relatives, and friends when they are involved with, or need help from, children's services in England**. Their advice service is funded by the Department for Education. Their expert advisers are experienced lawyers, social workers, and family rights advocates, who help families understand the law and child welfare processes when social workers or courts are making decisions about their children. The service aims to help families work constructively with children's services to get the best outcomes for their child/children.
