### What is Prevent?

**Prevent** is the name given to a national strategy which aims to stop people from becoming extremists, being radicalised or supporting terrorism. Prevent aims to deal with all forms of extremism including extreme right/left wing, racist extremism, animal rights extremism, religious extremism and mixed ideologies.

All staff and volunteers have a duty to;

- attend Safeguarding and Prevent Duty Training as identified or provided by their institution, See HCC Learning Zone
- uphold the values embedded within the Equality Act 2010 and embed these values into their practice
- use any relevant opportunities to promote these values
- report any safeguarding and/or Prevent concerns to the named staff responsible in their organisation.

**Learners need to be able to understand and articulate what Prevent is, the risks and threats, including local threats.**

### Prevent – Local Threat

- Extreme Right-Wing Terrorism; Hants and IOW received the highest percentage (24%) of all ERW referrals during 2022. Just under half of the referrals (47%) were for those aged 20 and younger.
- Use of the internet linked to terrorism/extremism, continues to be a key theme across the South East, in 2022 19% of Hants and IOW cases had an online, gaming or media as the primary tool for radicalising.
- There was a 38% decrease in Islamist Prevent referrals, however, for Hants and IOW the numbers remained consistent at 5% of all referrals.

Current threat level for England is **substantial**, which means an attack is likely.

**New: Prevent Duty Guidance**

The Prevent Duty was published on 7<sup>th</sup> September 2023 and although the updated guidance places no new legal requirements or additional responsibilities on education settings, there are changes that the education sector should be aware of.

The updated guidance won't come into effect until 31st December 2023 at the earliest.

## **A message from Counter Terrorism Policing Southeast (CTPSE)**

### **Vulnerability to radicalisation (V2R)**

We need to widen our gaze to consider V2R alongside awareness of other safeguarding risks such as domestic abuse, child sexual exploitation (CSE) or female genital mutilation (FGM) so we can spot the signs. The list below (not exhaustive) covers just some of the potential indicators -

| • Grievance                                   | • Blaming others                        |

If someone is vulnerable to radicalisation, they are unlikely to tell anyone or to reach out for support. Without help, they might go on to do themselves or society harm.

If you identify a V2R risk indicator in an individual's life, we need you to record those concerns and make a Prevent referral.

This enables professionals to intervene at an early stage and offer bespoke support to the individual. The earlier the intervention, the greater the chance of their being diverted away from the path that could lead to terrorism.
