HL19 – learner evaluation

The rating statements have now changed from 1-5 to 1-4. We would like tutors to make a concerted effort to get all learners to complete the end of course evaluation. This can be as a paper copy or an online word document or an electronic form (template on the VLE). If you use the electronic form, you can generate a QR code which enables those with a smart phone to get direct access to the form, whilst in the class session.

Attendance and punctuality

It has come to light that not all tutors are recording lateness on registers, please ensure that you record ALL learners who are late to the session regardless of the reason. The register is a legal document and must be an accurate record of attendance.

Absent learners

Please make sure you are aware of your providers process for contacting learners who were not in the expected session. All learners who are missing should be contacted to find out the reason for absence (unless they have already notified you). HA see this as a safeguarding concern if the whereabouts of learners are unknown.

Progression and enrichment opportunities

As you plan your courses for the autumn term please think carefully as to how you can promote further opportunities for learners to use their new skills/learning. Things that you could promote include local community groups, volunteering opportunities, local support groups, taking part in charity appeals (such as knitting/crochet) other courses either at the same level or at a higher level.

Tutor Survey

Thank you to those who completed our tutor survey. Individual providers have been given a copy of the responses for their own provision. The Key headlines from this survey are as below;

- Response rate of 66% (65 responses up from 42)
- 86% (56) felt well supported working for their provider (up from 82%),
- 93% (61) of tutors were offered CPD opportunities, this is an increase from 76% last year.
- 83% (54) said that the provider is **well led and managed**, this is an improvement from 72% in 2022.
- 85% (55) agree that their provider is **considerate of their well-being**, this is an improvement from 2022 when the response was 76%.

SAR and QIP

It is soon coming around to that time again when we start to think about finalising the provision type SARs that you have been contributing to over this last academic year, which I hope will not be too onerous a task as most have started to populate SAR narrative and stats within the Evaluate module of the Mesma GenII software. Prior to writing your final SAR, please do not forget to update all current QIP activity as this may inform your writing.

The cut-off date for your final SAR is 4th August. This date is non-negotiable to give colleagues time to review all SARs and translate this into the overall Adult Learning SAR for our Adult Learning provision.

Please do add any areas for improvement identified for 23/24 into Improve within GenII as this will be monitored through summaries on provider returns and at Performance and Quality meetings.
