#### **Preparing for Inspection**

As you are no doubt aware, we are expecting to have a **full Ofsted Inspection this academic year**, our preparations are well underway, particularly with the mini-ACL inspection that took place in the summer term. Where it was identified improvements were needed, we know that you will be working hard to address those actions, thank you.

An Ofsted Inspection gives us an opportunity to show off what we do well, which is meeting the individual needs of all our learners, they are at the heart of what we do and why we work so hard. # **Teaching Pedagogy:**

#### Learner Engagement

In her literature review of research into student engagement, Vicki Trowler (summarising Fredricks, Blumenfeld & Paris, 2004) describes three ways in which learners may or may not be effectively engaged with learning:

- 1. **behavioural engagement** learners who are behaviourally engaged would typically comply with behavioural norms, such as attendance and involvement, and would demonstrate the absence of disruptive or negative behaviour;
- 2. emotional engagement (for robust intrinsic motivation) learners who engage emotionally would experience affective reactions such as interest, enjoyment, or a sense of belonging;
- 3. cognitive engagement cognitively engaged learners would be invested in their learning, would seek to go beyond the requirements, and would relish challenge. Pedagogies Glossary (warwick.ac.uk)

Designing and delivering teaching so that all learners can participate equally well, regardless of disabilities.

Ensuring that teaching does not discriminate against learners, regardless of their individual backgrounds and identities.

### **Prevent – Local Threat**

• Extreme Right-Wing Terrorism; Hants and IOW received the highest percentage (24%) of all ERW referrals during 2022. Just under half of the referrals (47%) were for those aged 20 and younger.

• Use of the internet linked to terrorism/extremism, continues to be a key theme across the South East, in 2022 19% of Hants and IOW cases had an online, gaming or media as the primary tool for radicalising.

• There was a 38% decrease in Islamist Prevent referrals, however, for Hants and IOW the numbers remained consistent at 5% of all referrals.

# **Reminder MIS Update**

There are changes to the ILR specification for 2023-24 which result in changes to the recording of ACL learners on EBS. The following additional information will now need to be recorded for all learners enrolling on ACL courses in 2023-24

- Employment Status
- Prior Learning Level

Those of you involved with the Multiply project will already be familiar with these fields but there will be a new version of the Data guidance Notes to cover the additional requirements in due course.

In addition, Community learning courses will have to be reported under the following 7 delivery strands which link to the Community Learning objectives

- Engaging and/or building confidence
- Preparation for further learning
- Preparation for employment
- Improving essential skills (English, including English for Speakers of Other Languages, maths and digital provision)
- Equipping parents/carers to support children's learning
- Health and well-being
- Developing stronger communities

These will replace the four strands (PCDL, NLDC, WFL and FEML) that have been used previously.



Details of how this information is to be recorded will be included in the Data Guidance notes and a new version of the Community Learning enrolment form for 2023-24 will be produced to collect the information required.
